The Government of Kenya has received financing from the World Bank towards the cost of the Kenya Youth Empowerment Project (KYEP), and intends to apply part of the proceeds for consultant services. KYEP has three components coordinated by the Office of the Prime Minister and KEPSA is mandated to implement Component 2 of the Project; Provision of Training and Internship to approximately 11,000 youth aged 15-29 years in the private sector over the period 2011 to 2014. The project will start in Nairobi in the first cycle and roll over to Mombasa and Rural location yet to be identified in the subsequent cycles.

The consultant services will include Beneficiary Assessments and the selected Firm will specifically be responsible for:

- i) Finalization of data collection tools (Quantitative and Qualitative);
- ii) Designing the sample selection for both quantitative and qualitative assessment; Plus
- iii) Data Collection, Data Entry, Analysis and Reporting.
